Structure and Governance

Badenoch and Strathspey Orienteering Club is a SCIO (Scottish Charitable Incorporated Organisation) governed by its constitution. SCIO status was granted by OSCR in February 2022. Trustees are recruited and officially appointed at the AGM each year.

sport of orienteering (in all its forms and at all levels of ability), particularly among local communities, including encouraging the growth of public participation in recreational orienteering and developing the provision of orienteering facilities and activities in these communities, and specifically.

to promote the sport of orienteering for the long-term sustainability of the club.

- to be a responsible, active, friendly and competitive club.
- to provide regular orienteering opportunities at all levels.
- to develop pathways to support members to reach their potential.

Achievements and Performance

The main focus of the club has been the weekly training sessions on Tuesday evenings with club members taking turns to organise the training. Since becoming a SCIO we have run 34 sessions, with some 260 non-unique participants taking part. Of these 260 participants, approximately 98% were club members, all of whom came to multiple sessions. All our Tuesday sessions were in the Badenoch and Strathspey Area.

Short term Club Development Officer

In May/June we used Scottish Orienteering Association (SCIO) grant funding to employ two short-term Club Development Officers. They planned a series of 3 taster sessions for newcomers which were well attended (total 25 individual participants) and proved popular. They also assisted with social media and raising awareness of BASOC in the community.

BASOC Events

Events are organised competitions. Since becoming a SCIO BASOC has put on three events and was actively preparing for a large event on the 9th of October 2022, which falls outside

Within the reporting year we held the following events:

Attendance and success at other events

Our members attended many events over the course of the year, both low and high profile, including national competitions.

Compass Sport Cup, 12th March, Team of 12 and some good results The JK 2022, April, a national-level event, 2 members Jamie Stevenson, June, a Scotland-wide event focused on junior orienteers. 3 members, including 1 first place.

Scottish Champs, May, Many members took part and 7 achieved a podium place. One junior was re-selected for the ScotJos and GB North talent squads and represented Scotland the Junior Home Internationals and represented GB at the Junior European Cup in Germany. She also attended two training camps in Sweden. Two members were selected to represent Scotland at the Veteran Home Internationals.

SCIO

We are particularly proud to have become a SCIO and part of this year was spent learning how to operate as a charity and having our first two employees, the Club Development Officers.

Social

We had a number of socials through the year as we come out of COVID-induced habits. The number of socials in the following year is intended to be higher as we all learn to reengage.

The income this year has mainly come from membership, events, and donations.
